## **ACE COVID-19 Travel Requirements**

Like the rest of the world, ACE is navigating the challenges of travel in the age of COVID-19. While information continues to evolve, we wanted to give you the most updated information on what you will need to travel to Jamaica and back to the United States. Your ease of travel and safety in our care are our first priority.

TRAVELING TO JAMAICA FROM THE US (Jamaica order effective March 23 until June 30, 2021):

The following is REQUIRED:

- TRAVEL AUTHORIZATION FORM: Within 7 days from trip date, all travelers must complete and submit a form on the <a href="https://www.visitjamaica.com">www.visitjamaica.com</a> and print out an APPROVED form. This will be shown to the check-in desk at the airport and the Immigration officer upon arrival to Jamaica.
- NEGATIVE COVID TEST: Within 3 days (72 hours) from trip date, all travelers must be tested for Covid and received a negative result. Positive results will not be allowed to board the plane. All residents of USA (12 years of age or over) will be required to present to the airline check-in desk a negative COVID-19 PCR or Antigen test result that meets the standards of the World Health Organization (WHO) in order to complete check-in for the flight.

There is a test calculator on the <u>www.visitjamaica.com</u> site to determine the earliest test date accepted. Tests must be done by a medical laboratory that has a CLIA registration or ISO 15189 certification. Samples collected using home test kits (example: Pixel by LabCorp), along with antibody tests will not be accepted.

## **UPON ARRIVING IN JAMAICA:**

Galina Breeze Hotel is on the approved list of hotels and resorts on the Resilient Corridor for tourism. You will have already chosen this hotel on the list when you filled out your Travel Authorization Form.

You will present to the Immigration officer your approved Travel Authorization Form, your passport and a completed Hotel Confirmation Form (provided by ACE/Galina Breeze).

**TRAVELING TO THE US FROM JAMAICA (CDC/US order effective January 26, 2021 until indefinitely)** Within 3 days of your departure from Jamaica, the CDC now requires travelers to have a COVID-19 test and receive a negative test result in order to board the flight from Jamaica, OR a traveler may bring a confirmation from a doctor that the traveler has already had COVID-19 and has recovered.

## **ACE COVID TESTING:**

The following will take place for each traveler (2 years and older) unless you have an officially approved letter confirming you've previously recovered from COVID-19 (see above):

- ACE and Galina Breeze have arranged for testing sites on our ACE properties through a Jamaican physician within 3 days of departure date.
- The test will be a nucleic acid amplification or viral antigen test as required by the CDC.
- The test will cost each traveler \$100US (credit cards accepted).

## IN THE EVENT A TRAVELER TESTS POSITIVE BEFORE DEPARTING JAMAICA:

The airlines will *not* let you board the plane with a positive test result. Airline/flight changes will be the responsibility of the traveler. Quarantine accommodations by ACE will be made on a case-by-case basis.
